5 Regulation 4 repealed and replaced

Regulation 4 of the principal Regulations is repealed and replaced with the following:

"4 Payment of grant fee

- (1) A person whose visa application is approved must pay the grant fee specified om regulation 3 within 21 days after the visa is granted.
- (2) If the person fails to comply with subregulation (1), the application lapses and the person must make a new application."

IMMIGRATION (FEES) (AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by section 93 of the Immigration Act 2012, I make the following Regulations:

1 Citation

These Regulations may be cited as the Immigration (Fees) (Amendment) Regulations 2018.

2 Commencement

These Regulations commence on the date published by notice in the *Gazette*.

3 Regulations amended

These Regulations amend the *Immigration (Fees) Regulations 2013* (the "principal Regulations") (Legal Notice No. 111 of 2013).

4 Regulation 3 repealed and replaced

Regulation 3 of the principal Regulations is repealed and replaced with the following:

"3 Application and grant fees

For section 20(1) of the Act:

- (a) the application fee for a class of visa specified in column 1 of the table below is the amount specified opposite in column 2;
- (b) the grant fee for a class of visa specified in colum 1 of the table below is the amount specified opposite in column 3.
